Due the national coding for discharge method being 'patient discharged him/herself or was discharged by a relative or advocate' as one code until April 2023, the data does include those patients who were discharged by a relative or advocate.

As this was included in 2021 to April 2023, we have used the new codes of 'patient discharged him/herself' and added those who were 'discharged by a relative or advocate' so to keep the data aligned over all 4 years of data.

2. The reason for voluntary discharge is not captured on the electronic systems.
