Currently AI tools fall under existing risk assessments under Medical Devices, IG and Clinical Safety Processes. Tailored framework for AI assurance is under development. f) Details of any group responsible for the oversight of Al use within your organisation.

The Trust has established an Al & Automation Steering Group which reports to IM&T Council and meets monthly.
