#### 1.12. Procurement Framework Used

The electricity contract was procured through the **Crown Commercial Service (CCS)** framework for Whiston & St Helens Hospitals.

Southport & Ormskirk Hospitals electricity contract was procured through COCH.

#### 1.13. Notice Period / Break Clause

The contract allows the Hospitals to give Smartest Energy **no less than 25 business days' written notice** for any changes related to meters or service providers for Whiston & St Helens Hospitals, there is none in place for Southport & Ormskirk Hospitals.

#### 1.14. Earliest Date Notice Can Be Served

Notice can be served at any time, provided it meets the 25 business days' requirements. Southport & Ormskirk Hospitals unknown.

# 1.15. Contract Type

The current electricity contract is a **fixed price contract** for both Whiston and St Helens Hospitals. Southport & Ormskirk Hospitals flexible.

## 1.16. Use of Energy Broker

Yes, the contract was procured with the assistance of an energy broker, **Sustainable Energy First** for both Whiston and St Helens Hospitals. Southport & Ormskirk Hospitals through Inspired.

#### 1.17. Broker Commission

A commission of £31,990 per annum was paid to the broker for the product services contract covering the period from 1 October 2024 to 31 March 2027 for both Whiston and St Helens Hospitals. Southport & Ormskirk Hospitals £1,150.

#### 1.18. Power Purchase Agreements (PPAs)

No power purchase agreements are currently in place with renewable electricity generators for all sites.

## 1.19. Details of PPAs (if applicable)

Not applicable for all sites.

#### 1.20. Proportion of Electricity from Renewable Sources

The electricity supplied under the latest procurement contract from October 2024 is **100% conventional**, meaning no renewable energy is included in the supply mix.

However, renewable electricity is generated on-site at St Helens Hospital through solar PV systems. The newest system, installed on the roof of the Diagnostic & Treatment Centre (DTC), became operational in 2025. An earlier, smaller-scale system was installed at Horton Lodge in 2022. The total installed capacity of solar PV at St Helens is 228.04 kWp, and all electricity generated is consumed directly on-site, with no export to the DNO network.

All electric purchased for Southport & Ormskirk sites is from renewable sources.

# 2.1. Current Gas Supplier

The current gas supplier for Whiston and St Helens Hospitals is **TotalEnergies** Southport & Ormskirk Hospitals Corona Energy.

#### 2.2. Start Date of Current Contract

The gas supply contract commenced on **1 April 2025** for both Whiston and St Helens Hospitals. Southport & Ormskirk Hospitals 1<sup>st</sup> April 2023.

#### 2.3. End Date of Current Contract

The contract is scheduled to end on **31 March 2028** for both Whiston and St Helens Hospitals. Southport & Ormskirk Hospitals 31<sup>st</sup> March 2027.

#### 2.4. Total Number of Meters

There are a total of **three gas meters** under this contract: two serving Whiston Hospital and one serving St Helens Hospital. Southport & Ormskirk Hospitals 11 meters.
